

UNCONDITIONAL AND FULL GENERAL RELEASE AND AGREEMENT RON TURNER FOOTBALL CAMP (MINOR CHILD)

Every Guardian of a Minor participant must have signed this Unconditional and Full General Release and Waiver and Agreement – Ron Turner Football Camp (Minor Child) for such participant to participate in the “Ron Turner Football Camp” “Ron Turner Football Camp” is an event held at the Jacksonville Jaguars Florida Blue Practice Fields (such Practice Fields and the surrounding premises on which the Activities occur, collectively, the “*Practice Fields*”), with organized activities planned by Florida International University (“*FIU*”) and Ron Turner Enterprises, and their designees, including, without limitation, [[add in all specific drills/activities not listed in following statement] on-foot drills and obstacles, catching a football, throwing a football, contact on padded ground and contact and obstacles involving football inflatables] (collectively, the “*Activities*”). In consideration of FIU, Ron Turner Enterprises allowing participation in the Activities, I hereby agree as follows:

Liability Release; Indemnity: I, [redacted] (print name), as parent and/or legal guardian (“*P*” or “*Guardian*”) of [redacted] (print name), a minor (“*Minor*”), hereby agree to, and grant the permission necessary for Minor to, participate in the Activities and **expressly assume all the known and unknown risks inherent in the activities included in the Activities** (which may include, among other things, broken bones, cuts, scrapes, bruises, sprains, blisters, fractures, jammed fingers, contusions, concussions, permanent disability, paralysis, death, and other ailments associated with participating in the Activities, and injuries from other participants or as result of Minor’s or Guardian’s own negligence).

As Guardian, I, on my own behalf and on behalf of Minor, release, covenant not to sue and forever discharge FIU, Ron Turner Enterprises, FIU Board of Trustees, the Florida Board of Education, the Jacksonville Jaguars, LLC (“the Jaguars”), the Jaguars sponsors, the operator and/or manager of the Practice Fields, any vendor providing services at the Activities, the National Football League, and their respective directors, officers, owners, members, managers, partners, representatives, agents, employees and affiliates (collectively, “*Releasees*”) of and from any and all claims, demands, suits (including in equity), causes of action, judgments, losses, liabilities, damages, costs and expenses of any nature, **whether caused by, arising out of or based on the active or passive negligence of any Releasee or otherwise**, arising out of or in any way connected with Guardian’s and/or Minor’s participation in the Activities and/or any activities conducted at the Activities and/or otherwise occurring on the Practice Fields and/or travel to or from the Practice Fields, including, without limitation, any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and/or death) (collectively, the “*Claims*”).

I, as Guardian, hereby further agree to defend, indemnify and hold harmless Releasees and their respective heirs, successors and assigns from and against any and all such Claims, including, without limitation, attorneys’ and other professionals’ fees and costs. I understand that this release and indemnity includes, without limitation, any Claims based on the negligence, action or inaction of any Releasee (including in procuring medical treatment for Guardian or Minor), and covers personal and bodily injury (including death), and property damage, whether suffered before, during or after the Activities.

Assumption of Risk: I, on my own behalf and on behalf of Minor, acknowledge and agree that participation in the Activities involves certain risks, including those outlined above, and the possibility of physical illness or injury (minimal, serious, catastrophic and/or death), and I, on my own behalf and on behalf of Minor, assume and agree that Minor assumes the full risk of any injuries, damages or losses may be sustained by participating in the Activities. I, on my own behalf and on behalf of Minor, acknowledge and understand that participation in the Activities requires physical contact with other participants in the Activities. I, on my own behalf and on behalf of Minor, acknowledge and understand that participation in the Activities requires vigorous physical activity. I represent that I am and that Minor is mentally sound, in good physical health, and fully capable of participating in the strenuous activities relating to the Activities.

Supervision: As the parent or legal guardian of my child, I understand and agree that I am solely responsible for myself and Minor, and that Releasees cannot and will not be responsible for Minor before, during or after the Activities.

Medical Treatment: I, on behalf of myself and Minor, authorize FIU, Ron Turner Enterprises, and its designees to procure, at my expense, any medical care (including any emergency medical or surgical procedures provided by a physician, trainer, or nurse) reasonably required for Guardian or Minor (including, without limitation, during any visit to a hospital or facility selected by FIU and/or Ron Turner Enterprises) during the Activities. I understand that I am fully responsible for all hospital, laboratory and doctor fees.

Grant of Rights: I, on behalf of myself and Minor, irrevocably grant permission to Releasees (i) to photograph, take motion pictures of, or televise, and reproduce in any manner or through any media the image and voice of, Guardian and Minor; and (ii) to use, display, license or sell the name, likeness, voice, biographical data, appearance or image of Guardian and/or Minor in motion pictures, telecasts, publications, distributions or reproductions or any other media now known or hereafter developed, in each case, for any purpose (commercial or otherwise), without reservation or limitation and without compensation to Guardian or Minor.

Governing Law: This general release and agreement shall be governed by and construed in accordance with the laws of the State of Florida. The state and federal courts of Duval County, Florida, shall have exclusive jurisdiction over any dispute arising out of or based on this general release and agreement.

Separability; Entire Agreement: If any provision of this general release and agreement, or the application thereof to any person or circumstance, shall to any extent be held invalid or unenforceable in any jurisdiction, (i) the remainder of this general release and agreement shall not be affected thereby and shall be valid and enforceable to the fullest extent permitted by law, and (ii) the court making such determination shall have the power to reduce the scope or applicability of such provision (including by deleting or replacing specific words and phrases) in a manner that makes such provision valid and enforceable and comes closest to expressing the intention of the invalid and unenforceable provision. This general release and agreement contains the entire agreement between the Releasees, Guardian and Minor with respect to the subject matter hereof, and supersedes any prior or contemporaneous agreement.

NOTICE TO GUARDIAN: PLEASE READ THIS FORM CAREFULLY AND COMPLETELY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT EVEN IF THE RELEASEES USE REASONABLE CARE IN PROVIDING THE ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THE ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY THAT CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM THE RELEASEES IN A LAWSUIT FOR ANY REASON (INCLUDING ANY PERSONAL INJURY/DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE) THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND FIU HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

I, ON BEHALF OF MYSELF AND ON BEHALF OF MINOR, HAVE READ THE ABOVE GENERAL RELEASE AND AGREEMENT (WHICH CONSISTS OF TWO PAGES) IN ITS ENTIRETY AND FULLY UNDERSTAND ITS CONTENTS AND HAVE SIGNED THIS DOCUMENT VOLUNTARILY AND OF MY OWN FREE WILL.
